AND BE IT FURTHER KNOWN that at the date hereunder written the last Will  
and Testament (a copy whereof is hereunto annexed) of the said deceased was  
proved and registered in the Principal Probate Registry of His Majesty's High  
Court of Justice and that Administration of all the Estate which by law devolves  
to and vests in the personal representative of the said deceased was granted by  
the aforesaid Court to  
HENRY SUGDEN WRIGLEY of 372 Newchurch Road, Rawtenstall, Lancashire,  
Bank Clerk nephew of the deceased  
CLIFFORD HAMER of 70 Summerseat Lane Holcombe Brook Lancashire  
Company Director and HAROLD SUTCLIFFE of 14 Lord Street Rawtenstall  
aforesaid Solicitor nephew also of deceased the Executors named in the said will.

And it is hereby certified that an Affidavit for Inland Revenue has been delivered  
wherein it is shown that the gross value of the said Estate in Great Britain  
(exclusive of what the said deceased may have been possessed of or entitled to  
as a Trustee and not beneficially) amounts to \$404.1.6 and that the net value of  
the estate amounts to £329.0.11  
and it is further certified that it appears by a Receipt signed by an Inland  
Revenue Officer on the said Affidavit that £21.17.8 on account of Estate Duty and  
interest on such duty has been paid.

I, SARAH LOUISA HART of Polefield Cottage Cloughfold in the County of  
Lancaster Widow hereby revoke all former Wills and Testamentary Dispositions  
made by me and declare this to be my last Will and Testament.

1. I APPOINT my nephew Henry Sugden Wrigley my late husband's cousin  
Clifford Hamer and my nephew Harold Sutcliffe to be my Executors and Trustees  
of this my Will and I GIVE to each of my Trustees the sum of Fifty Pounds if he  
shall prove my Will and act in the trust thereof and shall also act in the winding  
up of the estate of my late husband John Hart.

2. I GIVE the following specific legacies:-

- (a) The Silver Tea Service formerly belonging to my husband and myself to my  
niece Marie Kershaw
- (b) The volumes comprising The Children's Encyclopaedia to my nephew John  
Naylor Murgatroyd.
- (c) The Children's Treasury Books to be distributed by my Trustees amongst the  
children in the family as seems to them equitable.
- (d) My other books to be distributed by my Executors as to them seems  
equitable

3. I DIRECT that the Oak Table formerly belonging to my sister-in-law Sarah Evelyn Murgatroyd shall be returned to her without any payment.

4. I DECLARE that my personal jewellery and personal belongings shall be distributed in accordance with a list which I have deposited with my Executors.

5. I GIVE my Share and other monies (if any) in the Cawl Terrace Cooperative society to the children of my nephew the said Henry Sugden Wrigley and my niece Enid Mary Sutcliffe who shall be living at my decease in equal shares absolutely.

6. I DECLARE that any other property real or personal which shall be standing in my name at the date of my decease after payment of the above legacies and my debts and funeral expenses shall be and form part of the residuary estate of my late husband John Hart and shall be disposed of in accordance with the terms of his will and I DIRECT (if this be necessary) that my Trustee shall have all powers to carry out the terms of my said late husband's Will.

7. I do not desire that there shall be a sale by auction of any of the furniture and effects belonging to me or my late husband on the premises. I desire that same should be offered in the first place to the relatives of myself and my late husband and our intimate friends and failing purchase by them that they should be removed to a sale room for sale purposes.

8. AND I DECLARE that any person who may be appointed a Trustee of this my Will who is a Solicitor or engaged in any profession or business shall be entitled to charge and be paid all usual professional and other charges for work or business done or transacted by him or his firm in the execution of or in connection with the trusts hereof including work or business not of a strictly professional nature which a Trustee not being a Solicitor or engaged in any profession or business could do personally.
