Craven Hoyle, J.P., of Leabank Hall, Cloughfold, was elected to the position. Mr Maden enjoyed the unique distinction of having been Mayor at the Coronations of both King Edward and King George, and also in the Diamond Jubilee year of Queen Victoria, while he was Mayor of Bacup throughout the entire reign of King Edward – a record unparalleled throughout the incorporated boroughs of the kingdom.

Colonel Hoyle Invalided Home

Lieutenant-Colonel J. Craven Hoyle, V.D. of Leabank Hall, Cloughfold, near Rawtenstall, on account of the state of his health, is returning home from Egypt, where he was in charge of a section of the East Lancashire Territorials. Colonel Hoyle is the Conservative candidate for Rossendale and opposed Mr Lewis Harcourt, M.P., there at the last election.

Work of Lancashire Territorials in Egypt

Colonel J. Craven Hoyle, J.P., V.D, of Leabank Hall, Cloughfold, has arrived home from Egypt having been granted six months' leave on account of a breakdown in health. Colonel Hoyle went out in command of the 5th East Lancashire Battalion in September last.

In an interview, he stated that the battalion's first camp was at Ismailia, on the Suez Canal. At the time rumours were about of the threatened invasion of Egypt by the Turks. After being encamped there until three weeks ago, they went into barracks at Abassina – a welcome change after practically six months under canvas.

The local men, he said, quickly settled down to their military duties, and behaved most commendably. The heat proved rather trying at first, and the sandstorms in the desert were troublesome, but they kept up wonderfully well.

Colonel Hoyle never missed a single parade of the battalion until January 7, when the breakdown in his health took place.

The 5th Battalion had not been in action at the time he left Egypt, though they were always prepared for any possible attack. During his stay in Egypt, he had been shown much kindness, and his associations with the officers of the Australian, New Zealand, and Indian troops had been of the most enjoyable description.
