Cowert. Wiche seyd order, Judgement, and dome of us the above namyd the seyd Jurdan as yet refusith and denyth to doo, contrary to all gud Right and conciens and his faith and fidelite and contrary to his seyd agreement thereof by us aforenamyd maide, Wherupon he then was contentyd. For so moche as well we the Inquest off office as the Inquest of the forest of Rossendale Sworne for our souerand Lord the Kyng, presentith this above wrytten to be of truyth by this our wardith and decide to answer unto for the same if neyde therin shall requier. Wherin we pray that for this cause Reformacien may be haid herin by the Kyngs concell of his duche and Master Stuard, accordyng to gud conciens, equite, and iustice'. (pp 58-9)

Thomas Brygge of Roclyff Wodde, of the age of 30 years, "deposith and seith that he and Agnes his mother haue ben tenntts unto the lait Abbott of Whalley attaynted of Heigh treason, by the sapce of threttye yeres by paste," and paid to the said abbot for the half of Roclyff Wodde 5s. in the year and 8s 4d to the Receiver of the Duchy; and since the death of the said abbot unto John Braddell, Balyff of Whalley 5s yearly and 8s.4d. to the said Receiver.

Item. - Richard Heipp of Rossendale, 60 years of age, deposith that one Robert Haworth occupied the other half of Roclyff Wodde in the manner as the aforesaid Thomas Brige deposith, "and affere as the seid deponent knowith the seid abbot never fynd for the seid land but dyd holde it as tenunt at will of the Kyng our

Souerand lorde for xvjs. viiijd. in the yere, wiche is to the Full value of the same lands."

Item:- Thomas Gryme of Baxstonden, age 30 years, deposith that he by the space of nine years by past was tenant unto the late abbot and paid yearly for a parcel of vachirye called Baxstonden, which late was in the tenure of Rawff Holden, called the Calff Hey, to the said abbott 6s.8d. and also 7s.1d. to the Receiver; and has since paid the said sums as before named. The said abbot fined for the parcel of vachirye of 7s.1d. rent.

Item:- Robert Smyth of Blakeburne, aged 40 years, deposith that Robert Smyth of Burneley his father, which "dyed now of lait" did hold a mese and 21 acres of land of the said abbot and his predecessors for 40 years, paying 26s.8d. yearly, besides 7s. to the hands of the King's Reves of Ightenhill; and he the said Robert still holdeth the same.

Item:- Robert Caryor of Penhulton, aged 46 years; John Whittacr of the same, aged 72 years; Richard Tynkenell of the same, aged 56 years; William Sydgreves of the same, aged 30 years; and Margery Otts of the same, aged 56 years, depose that they were tenants of the said abbot, who did hold "thre oxgang of land and a halff by copye of Cote Rolle, conteynyng lxx acres of the Kyng's Manor of Penhulton 23s.4d. and also to the Receiver of the attainted lands of Whalley 50s.31/2d., "and leace ne tacke they have none but at the Kyng's pleasour." they say that one Richard Wodde of Penhulton hath land of the same holding lying in Grindell, paying 5d. one year to the Receiver and 4d. another year, and which land is parcel of the said oxgang. And further they depose that the wife of John Grene holdeth one toft with a garth for which she payeth 7d. to the Greave of Penhulton for Kyng's farm yearly and 3s.4d. yearly for rent to the Reciever of Whalley, which is the King;s copyhold land of the Manor of Penhulton.

And Forasmuch as ye apperyth by your certificate that dyuers landes…are encroached...

We therffor For certen consideracions us moving will and command you...to appointe seurall courtes... to be holden an dkept and thereupon...in consideracion off the trauaile and expenses that Edward Williams, gent, haith susteigned in and about the searching and Finding owte iff the same...doe admitte such persons as the said Edwarde Williams shall nominate and appoynte...to be tenantes off the said incroached lands...and that you graunte the same to the said persons...to be holden by copie off courte roll...Paing... heriottes and other duties...accordage to the customes off our said mannors...which parcelles hereafter ensue:

[Details relating to houses in Colne, Haslingden and Aitenffelde]

also certene landes and tenementes liyng and beying in Dedwincloigh and Wollfyndene, whiche one Letisce Jacson gaue and graunted to thuse off one preist in the Newe Churche off Rossyndale payng...thirtie shillinges.

And also we commande you...that you do ayde and asisste the persons which the said Edward Wylliams schall nominate unto you concerning the quiet occupacion off ye premisses; and that you do certifie the names off them Reffusing or Gainsaing to our chauncellor and counsaile off our said Duchie in our Duchie chambre at our Palois off Westminster in the mois off St Mychell next comying...

Yetten at our said Paloys under the seale off our said Duchie the vijth Daye off Aprill in the Fourthe yere off our Reign.

By virtue of which Commission and by the appointment of the said Edward Wylliams, gent., the following admittances were granted:-

[details relating to buildings in Haslingen]

Rossyndale. - Robert Hauworth, by the appointment of Edward Williams, gent., was admitted to certain lands lying in Deadwyncloigh and Wollffyndene (yearly rent, 16s 7³/₄ d.), by virtue, &c. Frauncis Nuttowe and his co-feoffeess forbade fine in right and title of the church newly built in the Forest or Chace of Rossyndale, and in the right of the Oueen's tenants and inhabitations there, viz., that they and their heirs might remain fined and seised thereof according to the custom of the Manor to the use and maintenance of a priest or Minister in succession to administer divine service and the Word of God to the Oueen's tenants and the inhabitants there accordying to the tenor and true intent of a Decree of our Lady the Queen bearing date the sixth day of February in the first year of her most excellent reign [1558-1559]. Richard Tayllor by the same appointment was admitted to certain lands in Deadwyncloigh (yearly rent 2s 2¾d) by virtue of the said Commission, and found sureties to reply to the same forbids as are above recited (except Ralph Asshton.). Fine 2s 2¾d.

Lawrence Tayllor by the same appointment was admitted to certain lands in Deadwyncloigh and Wofffyndene (yearly rent 2s 2¾d) parcel of certain premises given by one Lettice Jacson to the use of a priest "in the Newe Churche in rossyndale," and he found sureties to reply to the forbids above reciedt (except Ralph Asshton). Fine 2s 2¾d.

James Whittiker by the same appointment was admitted to certain lands and tenements in the same places 9yearly rent $8s\ 10^3$ 4d) by virtue, &c, and found

sureties to reply to the above-recited forbids (except Ralph Asshton). Fine, 8s 10³/₄d.' (pp 236-240)

Admittance sought and granted. Fine 8s 8 ½ d by the pledge of Barnard Towneley.' (p 14)

'Margaret Hasilham, widow, complained against Henry Cunluf of Dedwenclough in a plea of land because the said Henry unjustly, illegally and contrary to the custom of the manor detained from the plaintiff for a long time the sixth part of one messuage, other buildings, lands and tenements in Dedwenclough in the Forest of Rossindale, annual rent to the Queen 30s, and the third part of ½ d. 'Inquisition taken there of the Forest for the Queen to make enquiry upon the oaths of Lawrence Nuttall, John Ormerod of Gambleside, senior, Gilbert Birtwisill, Oliver Pillinge, Dionysius Hauworth of Crawshaieboth, junior, Dionysius Hauworth of Constableleigh, Christopher Bridge of Dedwenclough, Goerge Nuttall, John Lord als Bolton, hugh Pillinge of Tunsted, Ralph Hauworth of Musbury, Nicholas Russheton, Christopher Hargreaves, Ellis Cunlyf and James Gryme.' (p 38).

Henry, son and heir of Dionysius Hauworth, late of Costableleigh, deceased, complained against John, son of John Houworth, late of Oakenheadwood, deceased, in a plea of land viz, because the defendant had disseised the plaintiff of one messuage, other buildings, lands and tenements, meadows, grazing lands, pastures and mosses in Okenheadwood in the Forest of Rossindale, annual rent to the Queen 21s 8d, now or lately in the tenure of the said John Hauworth, the son, and Robert, his son. The plaintiff said the defendant had detained the premises from him for a long time and continued to do so. He also said that Dionysius Hauworth, his father, was the son and heir of Ottiwell Hauworth, now deceased, and that the said Ottiwell took inter alia the premises from the late King Henry VII, by virtue of a commission at the time of the division of the said Forest, by which the same Ottiwell, the plaintiff [sic] claimed title to the messuage, etc. the defendant denied the charge. A day was given the parties until the next halmote of the manor held at Accrington on Friday 26th May, 12 Elizabeth [1570]. And meanwhile a jury of twenty-four good and lawful men, Queen's tenants of the New Hold, was chosen by the greaves of the New Hold to make judgement between the parties. The jury were John Robinson of Oldlaund, Christopher Hartley of Barrowford, John Hargreaves of the same, Nicholas Robinson, junior, Edmund Stephanson, Christopher Robinson, son of Lawrence, Roger Hartley of Wycolar, Christopher Hartley of the same, Hugh Pillinge, Christopher Bridge of Greaveclough, John Lord, son of James, Alexander Hauworth of Dedwenclough, William Yate, George Hauworth of Hauworth of Accrington, George Ryley, Robert Ryley and Richard Pemberton. To matter, they retired behing the curtain. [?] Afterwards, having discussed the matter amongst themselves for a long time, being fully agreed and being prepared to give their verdict, came back to the bar. The said Henry Hauworth was solemnly

summoned but did not come or proceed with his action. Therefore he was in mercy of the court and the said John Hauworth, son of John, was to go without a day in respect thereof.

Annual rent to Peter Birtwisill and his heirs 5s. Admittance sought and granted. Fine 20d by the pledge of William Jenkinson.' (p 78)

14 June 13 Elizabeth (1571) Halmote Accrington

'Christopher Romesbothome complained against Edmund Romesbotheyme of Okenheadwood in a plea of broken agreement whereof the same Christopher suffered damage to the value of £20. The defendant denied the charge. The jury of Edmund Assheworthe of Wulfindenboth, Robert Assheworth of the same, John Wulfinden, James Tattersall of Dedwyncloughe, Christopher Bridge of the same, George Dureden, Christopher Cronckshaie, Francis Bridge, James Pyccopp of Wulfinden, Goerge Nuttall, John Birtwisill and Edmund Lache found that the said Edmund Romesbothome broke and did not carry out the agreement made by him and the plaintiff and was therefore in mercy. Amercement 2d.' (p 85)

'Peter Byrtwisill of Dedwencloughe complained against John Bridge of Sedewast in a plea of trespass because the defendant had illegally and contrary to the custom of the manor used a certain way through the plaintiff's land and tenement in le Graystone Dole contrary to ancient use and where he had no right, whereof the plaintiff had suffered damage to the value of 40s. The jury of John Ormerod als Lodge, George Ormerod, Robert Assheworthe of Fernes, George Duerden, James Hauworthe of Crawshaieboth, Hugh Heighe, Oliver Romesbothome of Okenheadwood, Ralph Hauworth, Evan Assheworthe [Assheworth *crossed out*] Schofield, James Assheworthe of Lenches, William Tailior of Wulfinden and Edmund Asshweorthe alias Cheken found that the defendant ought to use the said way and that the plaintiff was in mercy for a false plea. Amercement 2d.' (pp 85-6)

'Peter Byrtwisill of Dedwencloughe complained against John Bridge of Sedewast in a plea of partition make not only of the ground in le Neweclose but alos of the fences there between the plaintiff and the defendant with metes and bounds according to the custom of the manor. The defendant denied holding any lands or fences in Neweclose. The jury of John Ormerod alias Loidg, George Ormerod and the other jurors said that they had made a division and partition of the lnads and fences as was clear by the metes and bounds put in place by them. Therefore the plaintiff was in mercy. Amercement 2d.' (p 86)

'James Lord of Bolton [sic] by John Lorde, his son, and with the said John Lorde and Christopher Bridge, complained against James Lorde of Bacopp, John Tattersall and Lawrence Rawstorne, gent., in a plea of trespass because the defendant blocked and stopped up ont usual way between Bacopp and one close of land called Calfscoteleighe. The jury of Robert Assheworth of Fernes, John Wulfinden, James Tattersall of Dedwencloughe, henry Kirshiae, Edmund Lache of Cowopp, George Duerden of Lovecloughe, Gilbert Birtwisill of the same, Oliver Romesbothome, Edward Taylor of Musbury, Evan Schofeild and Edmund Assheworthe alias Chekyne found that the defendants had obstructed the way contrary to the ancient use and custom of the manor and were therefore in mercy. Amercement 2d.' (p 86)
